CANADA EMERGENCY RESPONSE BENEFIT



The Government of Canada is now accepting applications to the new Canada Emergency Response Benefit (which is abbreviated as "CERB").

If you are eligible, there are two ways to apply:

Online



There are many steps for applying online.
This option might be confusing or overwhelming.

Phone



This is an automated voice system, so you do not talk to a human. You enter your personal information using the dial-pad on your phone.

We currently recommend applying by phone.

As of April 6, the phone is the easiest and fastest option. If this changes, we will update our recommendation.

Before you apply, you need to have:



Your Social Insurance Number (SIN)



Tip: your Social Insurance Number is 9 digits located here on your SIN card



Your Postal Code

Tip: if you do not know your postal code, you can look it up on the Canada Post website: canadapost.ca

Find a Postal Code

Look up a Canadian street address or postal code.

- Search street address, rural route, PO box or general delivery to get a postal code.
- Search by postal code to get a complete address.

Enter the address as a single line (for example, 1-19 Spadina Ave)

Because so many people will be applying to the CERB, you can only apply on certain days of the week.

Use the chart below to find your day to apply:

| April, May, or June | Tuesdays |
| July, August, or September | Wednesdays |
| October, November, or December | Thursdays |
| Any month | Fridays, Saturdays and Sundays |

Payment Information

The Canada Revenue Agency will issue payments by direct deposit or cheque, based on the payment method they have on file for you.

- Direct deposit 3 business days (approximately)
- Cheque in the mail 10 business days (approximately)

If your situation continues, and you're still eligible for the CERB, you can re-apply for a payment for multiple 4-week periods, to a maximum of 16 weeks (4 periods).
